ORDER

Akhila Kerala Yadava Sabha has represented through the Committee for the Welfare of the Backward Classes in the Kerala Legislature to include Maniyani, Kolaya, Ayar, Mayar, Iruman, Urali Nair, Konar, Pillai and Golla as a part of Yadava Community in the State List of Other Backward Classes.

2. The Yadava Community has already been included in the list of Other Backward Classes as item No. 76 of the List III in the Schedule attached to Part I of Kerala State and Subordinate Services Rules, 1958 as detailed below:

"76 Yadavas (Kolaya, Ayar, Mayar, Maniyani and Iruman)"

3. The request of Akhila Kerala Yadava Sabha has been referred to the Kerala State Commission for Backward Classes and the Commission has advised Government in exercise of the powers vested under section 9(1) of the Kerala State Commission for Backward Classes Act, 1993, to include "Erumakkar"

Community of Kerala in the List III—of Other Backward Classes in the Kerala State—in the Schedule to Part I of Kerala State and Subordinate Services Rules, 1958 under item 76 Yadavas, by amending the list. The Commission has also advised not to include Golla and Urali Nair Communities in the said list.

4. Government have examined the matter in detail and are pleased to accept the advice of the Kerala State Commission for Backward Classes to include "Erumakkar" Community in the State List of Other Backward Classes as a part of Yadava Community and order that item 76 of the list III in the schedule attached to Part I of Kerala State and Subordinate Services Rules, 1958, shall be amended as detailed below:

"76 Yadavas (Kolaya, Ayar, Mayar, Maniyani, Iruman and Erumakkar)"
