**ORDER**

As per the Government Order read as 1<sup>st</sup> paper above Administrative sanction was accorded for launching Overseas Scholarship Scheme for assisting financially poor but academically well performed OBC students seeking admission in rated Foreign Universities.

2. The Director, Backward Communities Development Department, vide his letter read 4<sup>th</sup> cited has requested Government to accord sanction to draw and disburse the amount of Scholarship .
3. Government have examined the matter in detail and are pleased to accord sanction to draw the actual amount required to be paid to each beneficiary who had executed the indemnity Bond and to disburse the amount to them subject to the following conditions and other parameters prescribed in the Government Order read as 1<sup>st</sup> and also to the terms and conditions in the approved format of the indemnity Bond.

- (a) The Scholarship amount will be released on the basis of confirmation letter from the Foreign University/Institution itself to the effect that no Scholarship/grant is paid by them.
- (b) The research/teaching assistantship, if any received by the beneficiary is to be with in the prescribed ceiling. (And if the same, exceeds the ceiling, the maintenance allowance shall be reduced correspondingly)


- (c) The expenditure in this regard may be debited to the Head of Account 2225-03-277-91 (plan) of Current year's Budget Estimates.
